No DocuSign account needed to view your GMA on AP Connect!

Team members in your producer house who are working on new and renewing business now are able to view the accompanying group master application on AP Connect — no DocuSign account required!

To view a group master application (GMA) in AP Connect, click on "Tasks" in the top menu:

- 3. Mark the Task as "Completed" after everyone has signed the GMA, either by DocuSign or via paper.
