The 2022 plan year for the Industry Health Trusts offered by Associated Industries is already off to a good start with the addition of new 7/1 anniversary dates for the Manufacturing and Retail Trusts. This valuable opportunity furthers our goal to simplify your workload by helping you diversify your book of business.

Some highlights to be aware of as you work with your new and renewing clients include:

- Your Manufacturing and Retail groups renewing January 1, 2022, will have the opportunity to take advantage of 18-month renewal offerings that will provide rate certainty through June 30, 2023.
- New groups enrolling from January 1, 2022, through June 1, 2022, will be offered rate certainty through June 30, 2023.
- Both renewing and new groups will only have one GMA for the above time frames.
