### **Business Health Trust Prioritizes Wellness with \$100 Healthy Workplace Credit for Vaccinated Members**

Business Health Trust and the Seattle Metropolitan Chamber of Commerce have announced a new Healthy Workplace Credit that awards member employers a \$100 credit for each employee covered by medical and is fully vaccinated against COVID-19. [Read the news release](#).

Please be sure you clients are aware that to claim the credit, your Business Health Trust groups must complete the [Employer Attestation Form](#) by January 20, 2022. Through this simple attestation, employers can indicate the number of employees who have received the COVID-19 vaccine, and they will then receive \$100 per employee as a credit on their account. This is an opt-in program, and the credit will show up on the employer's April 2022 bill.
