Introducing the Healthy Workplace Credit

Earn a \$100 credit for every fully vaccinated employee covered by BHT

Healthy employees are the foundation of a healthy business, and a healthy economy. That's why Business Health Trust is giving BHT member employers a \$100 credit for each employee who is participating in a BHT medical plan and is fully vaccinated against COVID-19.

Through the new **Healthy Workplace Credit**, BHT is investing in the health and wellness of our members. Vaccination is the key to keeping our workforce healthy and safe, and keeping plan costs down by reducing the risk of hospitalization and complications from COVID-19.

How it Works

BHT member employers must submit proof of vaccination for all employees participating in a BHT medical plan (Kaiser Permanente and Premiera Blue Cross plans) by January 20, 2022 to receive the Healthy Workplace Credit on their April 2022 invoice. The total amount of the credit will depend on the number of eligible vaccinated employees submitted.

How to Submit Attestation

Please complete the form on the back of this flyer and submit to BHT before January 20, 2022.

Timeline

- **October 2021–December 2021**—Encourage your employees to get vaccinated if they have not already done so.
- **January 20, 2022**—Submit your Attestation forms by the deadline.
- **April 2022**—Credit will be applied.
